<u>Woman Business Owner of the Year</u>—Presented to a woman business owner who's exemplified success through her business accomplishments and community involvement, despite any hurdles she may have had to overcome.

- What are the significant accomplishments of this nominee's business in the past year?
- What obstacles has she had to overcome?
- How has she demonstrated civic or community involvement?
- How has she demonstrated leadership, innovation, integrity and/or compassion?

<u>Women's Advocate of the Year</u>— Presented to a woman business owner who's committed to the growth of women-owned businesses, focused on helping women in need, and dedicated to building an organization that truly makes a difference.

- How does this nominee support the growth of women-owned businesses?
- How has she contributed to helping women in need?
- How is she building an organization that makes a difference?

<u>Trailblazer Award</u>— Presented to a woman business owner who's demonstrated talent, drive and innovation; is a pioneer in successfully developing unique products, services or delivery channels; and is a strong role model.

- How does this nominee demonstrate her talent, drive and innovation?
- What product, service or delivery channel has she pioneered?
- How does she serve as a role model for other female entrepreneurs?

<u>Signature Award</u> — Presented to a woman business owner who's been consistent and persistent in business practices for at least 10 years and who's demonstrated stellar leadership attributes within and outside her business.

- How long has this nominee owned her business? (Must be at least 10 years)
- What differentiates her from other veteran women business owners?
- How does she demonstrate her leadership skills?

<u>Green Community Award</u> — Presented to a woman business owner who's committed to going above and beyond in utilizing environmentally safe business practices, is a leader in the green movement and has encouraged others to be more green.

- How has this nominee gone above and beyond to utilize environmentally safe business practices?
- How has she demonstrated leadership in the green movement?
- How has she encouraged others to be more green?

<u>Rising Star Award</u> — Presented to a woman business owner who's achieved success in three years or less, demonstrated leadership skills and is considered "most likely to continue succeeding."

- How long has this nominee owned her business? (Must be 3 years or less)
- How has she met challenges or overcome obstacles?
- Why do you consider her to be a success?
- How has she demonstrated leadership abilities?

<u>Corporate Leader Award</u> - Presented to a woman in the business community of San Diego County who's achieved success within her business and in charitable work.

- How has this nominee been recognized within her company?
- How has this nominee demonstrated leadership to those on her team or within the circle of her peers?
- How has this nominee supported women-owned businesses in the community?
- How does this nominee provide service to her chosen charity(ies) and/or nonprofits, and what results have happened due to her good work?
